## **Authors**

Andrea Ampollini earned a BA in Philosophy from the University of Bologna (2018) and a MA in Philosophy of the Contemporary World from San Raffaele University of Milan (2021), spending a semester at the University of Leuven. Under the supervision of Professor Andrea Tagliapietra and Professor Alberto Burgio, he worked on a thesis concerning the idea of crisis in modernity. His research focuses on the history of ideas, conceptual history and history of modern and contemporary philosophy, with particular attention to authors like Marx, Nietzsche and Hayek.

MICHELA BONATO is an early career researcher specialized in Chinese Urban Studies. She received a PhD in Human Geography from Heidelberg University in 2020, and she has been a visiting research fellow at the Institute of Geography, Chongqing Southwest University. She currently works as a teaching assistant at the Department of Asian and North African Studies at Ca' Foscari University of Venice, and she is also an adjunct lecturer of Didactics of Geography (Introduction) at the University of Pavia (year 2022). Her research interests lie at the intersection of urban, political, and linguistic geography, focusing on urban space production, landscape management, heritage manipulation and political narratives in Southwest China.

Manlio Della Marca (www.manliodm.com) is an Americanist specializing in the intersection of literature and emerging media. After completing a PhD in Literatures in English at the Sapienza University of Rome, from 2017 to 2022 he was an assistant professor of American Literature at LMU Munich, where he continues to be the co-curator of the Eva Hesse Archive of Modernism and Literary Translation. His publications include essays on Ezra Pound, Edith Wharton, Thomas Pynchon, Philip K. Dick, Maxine Hong Kingston, and Leslie Marmon Silko. He is currently working on a book titled *Homo Legens: Modes and Moods of Reading*. Since 2019, he has served as book review editor of the *Review of International American Studies (RIAS)*, the flagship journal of the International American Studies Association.

LIDIA DE MICHELIS is professor of English and Anglophone Literatures and Cultures at the University of Milan. She is the author of monographs on Thom Gunn, Daniel Defoe, and the discursive politics of New Labour, and of edited collections and essays on eighteenth-century literature, twenty-first-century British culture and fiction, and the discourses of Thatcherism. Her current research focuses on nationhood, citizenship, asylum, fictional representations of illegalized immigrants, the imaginative impact of the sociology of risk on contemporary British novelists, and post-transitional South African fiction. Other research interests are postcolonial studies (South Africa, Black Britain, theories from the Global South), with a focus on migration and urban marginalization, the cultural and discursive politics of urban riots, austerity, precarity, Brexit, and the role of literature and the arts vis-à-vis the emergence of populism and post-truth.

ROBERTA GARRUCCIO, PhD in History of European Society, is tenured researcher in Economic History at the Department of Languages, Literatures, Cultures and Mediations at the University of Milan. After working in banking and business history, over the last decade she has been practicing oral history, investigating firms, organizations, and markets through in-depth interviews. She has been collecting several oral archives, and authoring and editing related publications on behalf of several institutions. Since 2015, she has been working in the field of Deindustrialization Studies.

DANIEL PALACIOS GONZÁLEZ received his PhD at the Universität zu Köln. He studied a MA in Cultural Policies at the Université Lyon 2 and the Univerzitet umetnosti u Beogradu, Serbia (UNESCO Chair for Interculturalism and Mediation in the Balkans), and a MSc in Community Cultural Development at the Universidad de Oriente, Cuba. He was MSCA fellow at the a.r.t.e.s. Graduate School for the Humanities Cologne and he is currently a member of the research project NECROPOL: From the Forensic Turn to Necropolitics in the Exhumation of Civil War Mass Graves at the Universitat de Barcelona.

ROBERTO PEDRETTI is an independent scholar in the fields of Cultural and Subcultural Studies. He has been an adjunct professor for over ten years at the Department of Language Mediation and Intercultural Studies, University of Milan, where he has taught English Culture, Cultural and Subcultural Studies. He has published book chapters and

essays on the history and culture of South Africa, on sports, music and populism and has co-edited several volumes pertaining to these fields. He takes part in the international inter-university project *Crisis, Risks and New Regionalisms in Europe*. In 2020 he authored *Dalla Lambretta allo Skateboard 2.0. Sottoculture e nuovi movimenti dagli anni '50 alla globalizzazione*. In 2021 he edited and translated, together with Claudia Gualtieri, *Gli studi culturali, il lavoro intellettuale e la pratica politica*, a collection of essays by Lawrence Grossberg.

ALESSANDRA PEZZA earned her MA and PhD from INALCO (Paris) and is currently a postdoctoral fellow at the University of Milano-Bicocca. Her research focuses on the role of contemporary Chinese literature in representing traumatic history and in transmitting Chinese cultural identity in China and abroad. She is responsible of communication and scientific coordinator for the translation research workshop *Officina di traduzione permanente* at the University of Milano-Bicocca. She translated, among others, works by Chi Ta-wei, Jin Renshun, Jin Yong, Lao Ma, Yan Lianke and Zhang Chu.

CINZIA SCHIAVINI is assistant professor of American Literature (RTD-B) at the University of Milan. Beside her two books (*Strade d'America*. *L'autobiografia di viaggio statunitense contemporanea*, 2011; and *Leggere Twain*, 2013), she has published on 19th and 20th century American fiction, nature writing and travelogues. Her current research is on contemporary Arab American theatre and culture, with a special focus on the post-9/11 turn.

Maaike van Berkel is a social and cultural historian of the Middle East, with a particular interest in literacy, court culture, governance, and urban organization. She studied Arabic Language and Culture and Medieval European History at the University of Amsterdam and obtained her PhD from the same university in 2003. From 2003 to 2015 she worked as a postdoc (with a NWO VENI grant), lecturer and associate professor in the History Department of the University of Amsterdam. In 2015 she was appointed to the chair of Medieval History at the Radboud University Nijmegen and in 2018 as head of the Department of History, Art History and Classics. Her current research project investigates water management in the premodern Middle Eastern city.

Frederik Van Dam is assistant professor of European Literature at Radboud University, Nijmegen (NL). His scholarship is situated at the intersection of intellectual history and literary criticism, with a focus on the long nineteenth century. He is the author of Anthony Trollope's Late Style: Victorian Liberalism and Literary Form (2016) and the co-editor of The Edinburgh Companion to Anthony Trollope (2019). His articles have appeared in journals such as English Literary History, Studies in Romanticism, and Partial Answers. His most recent work revolves around cultural diplomacy in the interwar period, with particular attention to Hungarian literature. He is the book review editor of the European Journal of English Studies and a member of the Radboud Young Academy. In 2015, he interviewed the éminence grise J.
