No work with copyright permissions pending will be accepted. The sources of figures and tables reproduced from other publications must be cited.

3. On-line publication is an additional service to the publication in print and does not imply any additional cost. LED disclaims any liability for the possible improper use of the published works and materials by users of the web site or by third parties.

4. The publication, both in print and on-line, does not imply any transfer of copyright by the Authors to the Publisher: the Authors simply authorize the publication as described in this document. The copyright of the content is maintained wholly by the respective Authors, while the editorial format and the graphical layout of the works published in print and/or on-line by LED remain the exclusive property of LED.

The final decision is the responsibility of the Executive editor, and will be taken within six months of receipt.

10. In case of more authors, the Corresponding Author will handle all correspondence with the Volume/Series/Journal editors.
