1. ONLINE OPEN ACCESS PUBLISHING

Consistent with open access policies, full texts published by *Led on Line* at www.ledonline.it can be accessed in their entirety free of charge.

Journals and periodical issues are published under Creative Commons licenses.

Books are published open access upon agreement among LED, authors, editors, sponsoring Institutions. If not specifically agreed upon, LED retains the right to publish open access all collections of essays by various Authors three years after the first publication.

4. AUTHOR GUIDELINES

BASIC GUIDELINES

Quotations and References should follow instructions and examples provided in the "Author Guidelines" of each Journal/Series.

When not otherwise specified, follow the **author-date system** of citing references, as described in: *The Chicago Manual of Style*. Chicago: University of Chicago Press - <http://www.chicagomanualofstyle.org>, or in *American Psychological Association Publication Manual* - <http://www.apastyle.org>.

The guidelines below should be followed in any case.

Works written in English by non-native speakers should be checked by a native English speaker prior to submission. Please provide a suitable statement.

- The **hierarchy of headings** is very important, as is **uniformity and consistency of the segmentation of the text** into sections, sub-sections, and paragraphs. Headings should be numbered. Up to three levels of headings may be used (e.g. 1. 1.1. 1.1.1. 1.1.2. 1.2. - 2. 2.1. 2.2. 2.2.1. 2.2.2. ...). Further levels and blank lines which are not correlated to titles must not be used.
- There should be **uniformity and consistency in the use of bold, italics, underlining, and quotation marks**. Avoid combined use unless it is absolutely necessary. If possible, avoid the use of bold type and use italics instead. Avoid underlining in any case.
- **Punctuation** should be consistent, including where it is used in figures and numbering (thousands, decimals, etc.).
- There should be **uniformity and consistency in the use of capitalization** for acronyms, institutions, etc.
- **Avoid capitalization and small capitals for the names of authors. Capital and small letters are to be used.**
- Please use **double quotation marks "..."** for quoted material up to 40 words.
- **Quoted material of more than 40 words** should be displayed in **smaller type** as an **indented block quote**, with a **blank line above and below, without quotation marks**.

FIGURES AND TABLES

- Photographs, drawings, graphs and graphics are all identified as **Figures**.
- **Figures can be reproduced only if they are free from copyright restrictions** or accompanied by a release for the specific volume. **Warning: Images on the internet**, even if declared "in the public domain", are almost never truly so. **The copyright always belongs to both the owner of the reproduced object and the photographer**. The fact that the photographer declares that the image is freely reproducible does not dispense with the need to obtain authorization from the owner of the photographed object (museum, archive, etc...). - **Figures and tables** should be **numbered consecutively** using two separate numerical sequences starting in each chapter from *Figure 1* and *Table 1*. **References to figures and tables** should always be quoted in the chosen position within the text, in the following format (*see fig. 00 – see tab.00*).
- **Figures (including graphs)** will be reproduced without any additional adjustment, with the same **definition and quality** as the original. All figures must be suitable for black-and-white print reproduction; readability in **grey scale** should be checked and optimized before submission.
- Figures must be both embedded into the text and also supplied separately in the **original electronic format** (.TIF, .JPG), **at the highest possible resolution and without any adjustments**, as resaving files may cause a loss of quality.
- When **drawings, graphs and graphics** are produced in Word and Excel, in order to maintain quality they should be supplied in **editable format** (not as images). All elements in **Word graphs** should be grouped using the Drawing toolbar.

FONTS

- Use unicode fonts (**Times New Roman, Gentium Plus or Charis SIL**), for **Greek, Cyrillic, Arabic and phonetical characters**.
- Use the **SimSun** font for **Chinese character**.
- Use the **Mincho** font for **Japanese characters**.
- In all cases of **transliteration into the Latin alphabet**, it is recommended to use accredited standards.

FORWARDING FILES

The essential elements are summarized below:

All texts must be submitted – carefully proofread and free of typos – both in MS Word and PDF format.

In order to guarantee optimal print quality, all figures included in the text must also be provided in their **original electronic format**.

To begin the process of publication it is necessary for the author or editor of the entire volume to sign the **“Authors’ and Editors’ Statement” for Books/E-books**, while authors of essays included in collective volumes / journal issues must sign the **“Authors’ Statement”**.

Authors of individual contributions to a collected volume / journal issue must send the completed and signed **“Authors’ Statement”** to the volume’s editor(s), who in turn will forward the form to the publisher.

These documents are available for download under “Agreements” on the page www.ledonline.it/ledonline/autori.

Along with the files and the countersigned copy of the contract, metadata and an image for the cover must also be sent.

5. PUBLICATION

Proofs in PDF format will be provided within five weeks after receiving the final materials. Proofs of more than 250 pages may take up to 2 months. If the editing and proofreading service is requested, additional proofs will be provided.

The editor of a collected volume (or journal issue) will decide whether to send the proofs to the individual authors, who in any case must authorize publication even if proofs are corrected only by the editor. In the case that proofs are revised by the individual authors, the corrections must be sent to the editor of the collective volume, who in turn will forward them to the publisher.

Final proofs will be provided within three weeks after receiving the corrected proofs. The text will be published in print, and with prior agreement open access, within 1 month after the approval of the final proofs.

The works will be published by LED in a definitive graphical layout but without any editing service, unless expressly requested.
