### AUTHOR GUIDELINES

*Linguae &* is a journal which provides a new outlet for interdisciplinary research on language and literature, giving voice to a cross-cultural and multi-genre koine. While the idea for the journal was developed in the ambit of the post-graduate programme in European Intercultural Studies at the University of Urbino, Italy, its scope goes far beyond that of exploring pre-established cultural paradigms. Indeed, its strongly experimental and dialogic approach to the ongoing debate should serve as encouragement for the submission of new work by young researchers.

Studies from a wide range of disciplines are welcome and will, each in their own way, contribute to the exploration and definition of a particularly complex field characterised by over-lapping, interwoven contributions and at times even unresolved differences. Thus, the journal constitutes a unique arena for exchanges of opinion, and should foster the bringing together of ideas, laying the groundwork for a new cultural itinerary.

No one language will be privileged in the journal, nor will any single culture predominate. The studies published will themselves, from one issue to the next, define the character of the journal: not for the sake of obtaining an "eclectic" array of contributions, but rather to leave ample room for the many voices which are currently enlivening the scholarly debate on linguistic, cultural and literary topics.

#### PEER REVIEW

*Linguae &* is a peer-reviewed journal. Invited papers will also be published.

**Only original articles are accepted for publication.** Submission of a contribution to this Journal represents certification on the part of the author(s) that neither the paper submitted nor a translation of it has been published or is being considered for publication elsewhere.

In submitting works to the journal, **authors agree that their works may be published (if accepted).** Submission of a work does not guarantee acceptance.

All submitted works judged suitable for review undergo **anonymous double-blind review** process.

**Papers** will be evaluated by at least **2 referees** and, following their indications, will be either accepted, or returned to the authors for corrections, or rejected. The final decision is the responsibility of the Editor in Chief, and will be given within **4 months**.

#### SIGNED CONSENT TO PUBLICATION

Authors must give signed consent to publication. **All submissions must be accompanied by the Authors' Statement form** signed by all the authors.

**Figures and graphs can be reproduced only if they are free of copyright restrictions, i.e. if they are in the public domain or accompanied by permission from the rights holder.**

**Images downloaded from the Internet** always require authorization unless expressly declared otherwise in the source.

**Figures taken from other publications** require consent for reproduction from the rights holders (museums, authors and/or previous publishers).

Authors should identify all materials and figures that require permission for publication and **provide the permissions on submission of the work to be published.**

#### TEXT ORGANIZATION AND STYLE

**Papers** should be no longer than **6.500 words** including quotations, references, and footnotes, tables or graphics.

An **Abstract** (not shorter than **120 words** nor longer than **150 words**) should also be supplied.

**5 keywords in English** should be supplied, **and, if the text is not in English, the same words** must also be given **in the language of the text.**

**Personal data** with affiliation and a short bio (up to 100 words) should also be supplied (in the "Author Profile" / "Bio statement").

If the **title contains fifty or more characters, submit a shortened version** to be used as **running head.**

**Misprints** should be eliminated. It is expected that authors submit **proofread** material.

The **hierarchy of headings** is very important, as are uniformity and consistency of the segmentation of the text into sections, sub-sections, and paragraphs.

**Headings should be numbered.** Up to three levels of headings may be used (e.g. 1. 1.1. 1.1.1. 1.1.2. 1.2. - 2. 2.1. 2.1.1. 2.1.2. 2.2. ). Further levels and **blank lines which are not correlated to titles must not be used.**

There should be uniformity and **consistency in the use of bold, italic, and quotation marks. Avoid combined use of bold and italic** unless it is absolutely necessary. If possible, avoid the use of bold type and use italic instead. **Avoid underlining.**

Please use **double smart quotes** ("...") for quoted material up to 40 words.

**Single smart quotes** ('...') can be used **inside a quote introduced by double quotation marks**, and – outside quotations – **to highlight a personal use of a term.**

**Use only smart quotes. Avoid straight quotes.**

**Quoted material of more than 40 words** should be displayed as an **indented block quote, with a blank line above and below, without quotation marks.**

There should be uniformity and **consistency in the use of capitalization** for acronyms, institutions, etc. as well.

**Avoid total capitalization and small capitals for the names of authors and for the titles and subtitles of your article. Initial capital and small letters are to be used.**

**Punctuation should be consistent**, including where it is used in figures and numbering (thousands, decimals, etc.).

#### FONTS AND SYMBOLS

**Greek, Cyrillic, Arabic and non-Latin fonts, and all phonetic and special symbols are to be given only as Times New Roman Unicode or Gentium Unicode or Charis SIL** (this also includes all phonetic symbols and the possible combinations of over/underdotted and over/underlined characters). **Authors should verify they use the latest updated release of the chosen font.**

At the end of the text, authors will supply **a complete list of all the symbols** they have used, **which do NOT belong to the basic Latin, Greek, Cyrillic and Arabic alphabets.**

#### FIGURES, TABLES, AND FORMULAS

**Photographs, drawings, graphs and graphics are all identified as "Figures".**

**Figures and Tables** should be **numbered consecutively using two separate numerical sequences** starting from *Figure 1* and *Table 1*. **References to figures and tables** should always be quoted in the chosen position within the text, in the following format and red characters (*see fig. 00 – see tab. 00*).

**All figures and tables must be accompanied by an italicised caption. An image caption follows the picture; a table caption precedes the table.**

**Figures can be reproduced only if they are free of copyright restrictions** (*see "Signed consent to publication" and Authors' Statement, Paragraph 2*). The **sources** of figures and tables reproduced from other publications should be cited.

**Figures (including graphs)** will be reproduced without any additional adjustment, with the same **definition and quality** as the original. All figures must be suitable for black and white print reproduction; readability in **grey scale** should be checked and optimized before submission.

**Figures must be embedded into the text and also supplied separately in the original electronic format** (.TIF, .JPG, .EPS or .XLS).

In order to guarantee a good printed rendition, **images must be high-resolution ones** (i.e. scanned at 300 dpi, or photographed at the highest possible resolution allowed by the used camera).

In order to result of good quality, **tables and graphs** deriving from Word, Excel, and yED **must be submitted in an editable format (NOT as images): tables and graphs in image format turn out very badly in print.** Or they would need a new very expensive typesetting (which also might cause mistakes).

The various elements of **Word schemata must be reciprocally linked together** according to the following procedure. **From the menu "Drawing". Select all elements and connect them with the function "group"** (*then move the grouped items in order to check that nothing remains detached*).

**Formulas** should be supplied in **MathType editable format (NOT as images or objects).**

#### CITATION AND REFERENCE STYLE

References and footnotes should follow the **author-date system** of citing references, as described in **The Chicago Manual of Style**. 17th ed. ([https://www.chicagomanualofstyle.org/tools\\_citationguide/citation-guide-2.html](https://www.chicagomanualofstyle.org/tools_citationguide/citation-guide-2.html)). For more details please refer to the **instructions** and **examples** provided below.

#### FOOTNOTES

**Notes must be linked to the note numbers in the text; they would otherwise be totally unusable when texts are prepared for layout** (*insert / reference / copy the note text inside its reference / verify that the note text is visualized when the note number is touched by the mouse*). References in the notes also follow the Author-date style.

Footnotes should be numbered consecutively. **Numbers of footnotes should always be positioned before the punctuation mark; only when at the end of the indented block quotes** they should be placed **after the final full stop.**

#### PARENTHETICAL REFERENCING

**All in-text and footnote references should be itemised in a List of References at the end of the text.**

**Multiple citations** should be in chronological order, and, if in the same year, alphabetical within year (e.g. Hartem 2004; Arkam 2005; Bolding 2005; Kent and Cowler 2006).

For works with **four or more authors** include **all authors only in the List of References**, while in the In-Text entry cite only the last name of the first author, followed by *et al.* (italics).

Where there is **more than one publication by an author in the same year**, add a letter to the year to distinguish them. Eg. (Smith 1999a).

In case of a series of references from the same source (**when no other is mentioned in between**) a bracketed number is sufficient to signal the page: (109). Please use (*ibid.*) when the same source is cited consecutively two or more times. If the same source but different page is quoted, follow '*ibid.*' with a comma and the new page number(s): (*ibid.*, 25). When writing inclusive numbers in the same hundred, the last two figures should be given (ex. 14-19, 34-37, 102-09, 1348-51), but 285-301 and 1348-520 (because the hundred also changes).

#### LIST OF REFERENCES

**Supply a list of references - under the sub-heading 'References'** – in alphabetical order according to the authors' surname, and place it at the end of the work. A list of references **should only include items cited in the text and notes.**

There should be **uniformity and consistency** in bibliographical references. **References should be complete.**

Please **double-check** to be certain that all dates given in parenthetical citations and in the List of references section are identical.

**Avoid total capitalization and small capitals for the names of authors. Initial capital and small letters are to be used. Use full names whenever possible.**

The titles of **volumes, journals, plays and films** should appear in italics.

The titles of **articles, chapters, poems and short stories** should appear in plain text, between **double smart quotes** ("...").

**Avoid straight quotes.**

**Subtitles of volumes** in French, German, Italian and Spanish are separated from the main title by a full stop, by a colon if they are in English.

**Subtitles of articles and chapters** in German and Italian are separated from the main title by a full stop; by a colon if they are in English, French and Spanish. Examples:

If persons are **editors**, follow the conventions of the place of publication: bracket **ed.** for single editor or **eds.** for multiple editors after the final name, followed by a full stop, if the text is in English: (ed.). Use (**dir.**) for French texts, (**hg. von**) for German ones, (**a cura di**) for Italian ones, (**coord. por**) for Spanish texts. Similarly, use **and, et, und, e, y**, respectively.

For books with **one author** use reverse name with comma. For books with **two or more authors** use same order as on title page (not alphabetical); only reverse name of first author.

**URLs** and the **DOI (Digital Object Identifier)**, where available, should be used to provide access information for electronic materials. The **latest access must be signalled** simply by day/month/year between brackets.

A separate section for **audio visual media** should be created in the List of References.

When works by an author who is also editor and co-editor are mentioned, list first those of which s/he is single author, then those of which s/he is editor and, finally, those where s/he is co-editor (each section in its own time and alphabetical sequence). Examples:

### OJS SUBMISSION PROCESS

In order to submit works to the Journal, and to check the status of current submissions, **authors need to register – selecting "Author: Able to submit items to the journal"** from the list "register as" – and login to the journal website.

If already registered, authors can simply **log in to enter their reserved area** where they can **"Start a new submission"** or check "Active submissions".

**All submissions must be accompanied by the Authors' Statement form** signed by all the authors. **In case of more authors**, co-authors may sign different copies of the statement and send them to the Corresponding Author.

**The statement/statements must be uploaded** (complete and duly signed) **by the Author or Corresponding Author together with the files being submitted** for publication.

Check that all **materials and figures that require permission** for publication have been identified and **provide the permissions on submission of the work to be published**.

In order to partially cover the costs of the review process, publication, and long-term archiving, this journal kindly requires the authors to pay a **limited submission fee (€ 50.00 - fifty Euros)** when uploading their papers. For the payment procedure see the **Authors' Statement form, point 1 a)**. Possible waivers are announced in the Announcements section.

**The online submission consists of 5 steps. All steps must be completed;** when done, the author will receive a confirmation e-mail. **If no confirmation is received** then the submission is incomplete: **please check that you have gone through with all the steps in the procedure**.

### FILE TYPES

All submissions must be in **Word** format.

A **PDF file**, generated from the final Word file on the same computer used to complete the work, should be supplied.

All **figures** embedded **should also be submitted in the original electronic format (300 dpi .TIF, .JPG, .EPS or .XLS)**.

The **Authors' Statement form/forms** (complete and duly signed by all the authors) has to be submitted.

**Publication permissions for any materials and figures that have copyright restrictions** have to be submitted.

**IMPORTANT NOTICE: Files maximum size allowed: 22 MB.** Files exceeding this limit must be splitted in two or more files. Use section *Uploading Supplementary Files* to upload files after the first one.

### ANONYMOUS FILES

To preserve the integrity of the peer-review process, every effort should be made to prevent the identities of authors and reviewers from becoming known to each other. **Please cancel any name from the file properties.**

Check that the online instructions in **Ensuring a Blind Review** have been followed.

**Pay attention! Personal data** with affiliation and a short bio (up to 100 words) should not be submitted in Word but **only in the "Author Profile" ("Bio statement")**.

### POST-ACCEPTANCE

**Proofs are sent to the Editors** of the Journal for review. **There is no proofreading by Authors.**

**The publisher is not responsible for any error not marked in the proof.**

Corrections on the proof can only be accepted for misprints; **no changes are allowed** at this stage.

All accepted works will remain permanently published on the website.
